COMMUNIQUE ISSUED AT THE END OF THE MEETING OF THE MEDICAL AND DENTAL CONSULTANTS' ASSOCIATION OF NIGERIA (MDCAN), COOUTH AMAKU- AWKA.

INTRODUCTION

The Medical and Dental Consultants' Association of Nigeria, Amaku- Awka branch at its Emergency Congress held at The Histopathology Auditorium, COOUTH, Amaku- Awka on Tuesday 5th of November, 2019 considered several issues of urgent importance including, but not limited to: the delay of the Government of Anambra State at approving and implementing the salary template that would resolve the agitation of Doctors and other workers who have not been promoted for once since the inception of the Teaching Hospital in April 2012.

Congress carefully considered the said issues and resolved as follows:

THE DELAY OF THE STATE GOVERNMENT OF ANAMBRA STATE AT APPROVING AND IMPLEMENTING THE SALARY TEMPLATE

The Congress noted with concern the undue delay of the State Government at approving and implementing the CONMESS template agreed at the committee set up by His Excellency on the 4th of July 2019. The MDCAN noted that her members had shown maturity and patience for 4 months despite being promised that the issues would be resolved in one month.

However, the Congress found it expedient to sheathe their sword as a mark of respect and honour to His Excellency, The Executive Governor of Anambra State whom we know is favourably disposed at alleviating our suffering at COOUTH, Amaku-Awka. **The congress further resolved to embark on an indefinite industrial action as from midnight of 30th November 2019 without the need for further deliberations on the floor of the House if the Government fails to reciprocate the trust and confidence the MDCAN has in her by delaying to sign, implement and commence the payment of the agreed salaries on or before the 30th November 2019.**
